# MAINTENANCE

### **Total Maintenance Work Orders for Last Month — 476**

With the summer months behind us, we all get to look forward to the cooler, colder and freezing autumn and winter months coming up! For those residents that have spent past winters with us, it will come as no surprise that Village 1 can turn into a wind tunnel. To help us all prepare for the changing seasons, there are a number of safeguards that we should all be making in and around your residences.

#### **Outdoor Furniture (Patio Sets, Pop Up Tents, Grills, Décor)**

In order to protect your property and neighbors, it is imperative that patio tables and chairs be pulled in towards your building to reduce the chances of them blowing away. This also applies to residents that have a grill or any outside décor around their unit. Those residents that have a temporary screened in porch or pop-up tent/canopy, it is recommended that you break down these and store accordingly. If you cannot breakdown these temporary structures, the covers/canopies/wall must be removed.

#### **Exterior Water (Sprinklers, Hoses, High-Rise Extensions)**

A major issue the Maintenance Department faced this Spring was an excessive amount of hose spigots that required replacement. In order to mitigate the amount of repairs to be made, the residents of Village 1 should begin to detach any connected hoses from the spigots. Not only should the hoses be detached from the spigots, but if you have a “high-rise” extension, all associated hoses should be disconnected from these as well. If you have an active sprinkler system at your residence, please make arrangements with a sprinkler company to come and winterize your systems. If you are unable to disconnect the hose yourself, please call in a request to the Maintenance Department and we will assist you at no charge.

#### **Air Conditioners**

For those residents that have wall unit air conditioning units, covers should be installed to reduce any drafts that might enter your unit. There are a number of commercially sold covers, the Maintenance Department also builds and installs these covers on an as needed basis. If you have air conditioner covers and need assistance or if you require air conditioner covers, contact the Maintenance Department to schedule an appointment.

#### **Whole Unit Winterizations**

A number of residents travel for the winter months. If you are one of these residents that travels, please make sure to properly store any outdoor furniture, disconnect any exterior water sources and cover your air conditioner as applicable. Whole unit winterizations are completed in an attempt to reduce high winter utility bills for empty homes and more importantly to safeguard against the chance of water lines freezing and potentially bursting, which will result in costly repair bills. If you know you will be traveling for an extended period during the winter months and would like to winterize your whole unit, contact the Maintenance Department a minimum of five (5) working days prior to the day you would like the work done. Same thing applies to those coming back from traveling and would like their residences “de-winterized”, a request must be made to the Maintenance Department a minimum of 5 working days prior. If you come home and then make a request to Maintenance for the de-winterization, it is not guaranteed that we will be able to accommodate you on that day or even the following day, as Manchester Township will also be involved and we are also subject to their schedule.

Additionally, don't forget that the Maintenance Department sells the paper lawn and brush bags directly out of the Maintenance Office. We are currently providing 5 bags for \$2.00.

On another unrelated subject, please make arrangements to have a copy of your house keys brought to the Maintenance Department. We maintain files for each of the units in Village 1 and always recommend that residents bring in a key for safe keeping. Very recently, we've had several occasions where a resident locked themselves out or experienced a medical emergency in which we would much rather prefer to use a key than the alternative of breaking off the lock and the resident paying for replacement or having emergency personnel kicking in the door. Maintenance will never use the keys on file to arbitrarily enter a residence, only when we are provided direct permission from the resident. We also will not provide the key to anyone other than the resident unless arrangements are previously made.

# RULES

**Obey the Rules or Pay the Fines**

14. Dumping of grass clippings or trash is **NOT** permitted in wooded areas. Garbage, trash and recycling pick-ups will be as regulated by the Board of Trustees. Remember, leaves, needles and pine cones must be placed in **BIODEGRADABLE PAPER BAGS ONLY**. These bags are available at our maintenance department or local stores.
15. When not in use, hoses are to be removed from lawns, walks and parking spaces. Lawns **will not** be cut if hoses are not put away.
16. Burning of papers or rubbish of any kind is not permitted. Fire pits and Chimneys are forbidden.
17. A compost pile of any kind is **NOT** permitted.
18. Wash or airing lines are not permitted in the open. They may be installed in the attic or garage. When in use in the garage, the garage door must be closed enough so that the wash is not visible from the street. Blankets, pillows or wearing apparel are **NOT** to be aired in the open.
19. Gasoline, gasoline containers, paint rags or other flammable materials are not permitted to be stored in the garage, porch, closets, attics, utility rooms or crawl spaces.
20. Patios no larger than 12' x 15' or 180 sq. ft. are permitted and must not obstruct natural drainage. They can be glass or screen enclosed. Written permission must be obtained from the Board of Trustees as well as a permit from Manchester Township where applicable. Enclosed patios are not permitted in the front of a building.

**RE: New Jersey Legislature S2425 and A3851**

Recent letters to the editor of various newspapers have stated the writers' opposition to a pending bill in the New Jersey Legislature (S2425/A3851) addressing common interest communities (The New Jersey Common Interest Ownership Act or "NJCIOA"). Notably, the concerns expressed with regard to this legislation have often been non-specific or unable to point to any provision of the bill to support the author's point and, most importantly, are false. Their apparent purpose is to spread fear within New Jersey's senior age-restricted communities. Statements have been made alleging NJCIOA "allows Trenton to meddle in the operations of age-restricted communities," or "it allows the taxation of HOA owners for the value of its common property," or "it does away with age-restricted communities as discriminatory", or, "it prevents an HOA from imposing rental restrictions." A review of the bill proves each of these allegations to be false.

The NJCIOA was drafted by the New Jersey Law Revision Commission ("LRC"), which is charged by law with reviewing, consolidating and simplifying New Jersey statutory law. NJCIOA seeks to initiate a process to consolidate the several different laws applicable to all types of common interest communities (homeowners associations, condominiums, and cooperatives), as a means of streamlining and making more efficient the day to day operations of these communities for the benefit of their residents.

In following the recommendations of the LRC's report, the NJCIOA establishes a new law to address the applicability of association law in general, and, more specifically, the taxation of common property, local ordinance applicability, the impacts of taking of property by the government, and the coordination between NJCIOA and other statutes. The bill also addresses the creation, alteration, and termination of common interest communities, fills the gaps left by many governing documents concerning delineation of unit boundaries and common elements, the content of the declaration and bylaws, lender rights, and the consolidation and termination of common interest communities.

The NJCIOA does NOT permit the State to “meddle” in the affairs of private homeowner associations, as alleged. It does NOT permit taxation of common property or adding the value of common property to individual owner’s property...in fact, it specifically prohibits it. The bill’s reference to New Jersey’s Law Against Discrimination (LAD) does NOT affect the ability of NJ’s senior communities to continue to be age-restricted. The LAD, which has banned discrimination based on age has existed since 1977, was amended in 2003 to explicitly exclude valid age-restricted communities from the age-discrimination provisions of LAD. The reference to the LAD in NJCIOA has NO impact on any association in New Jersey that complies with the federal Fair Housing Act’s provisions concerning 55+ communities. Obviously, the LAD has never been used to prohibit age restricted communities that are valid under the Fair Housing Act, nor does this legislation do so. And the bill in fact specifically authorizes an HOA to include leasing restrictions in its governing documents.

The sponsor of NJCIOA in the Senate, which passed by a vote of 34-2, has stated in his own letters to the editor that he would never have sponsored a bill that negatively impacts residents in New Jersey’s many common interest communities, particularly our senior citizens. Likewise, the New Jersey Chapter of Community Associations Institute (CAI-NJ), the members of which manage and serve these communities, would never support a bill that would harm any of the nearly 1.5 million residents who live and work in the nearly 7,000 common interest communities in New Jersey. With more than 2,000 members dedicated to building better communities, CAI-NJ develops and provides information, education and resources to volunteer association board members, community managers and other professionals who support the community association housing model. CAI’s mission is to inspire professionalism, effective leadership and responsible citizenship—ideals reflected in homeowners associations and condominium communities that are preferred places to call home. CAI-NJ supports this bill and its laudable goals.... we would not do so if it would do the harm that these false rumors say it would.

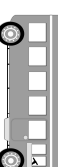
