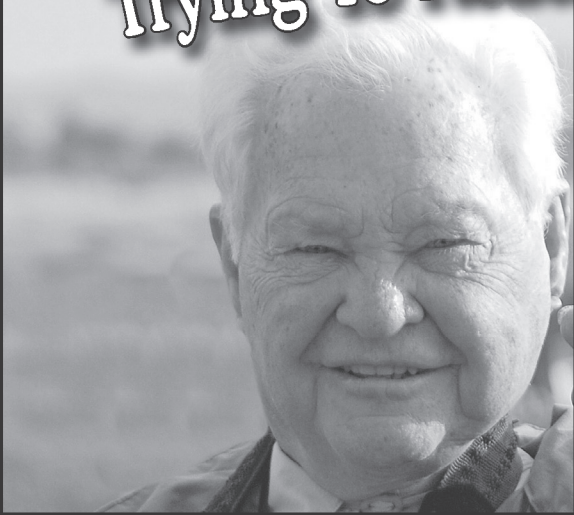

MAINTENANCE

MINUTE

Hello Residents of Village 1!

Over the course of the past few months, the Maintenance Department has responded to a number of calls directly related to poor workmanship of a hired third party subcontractor, uneducated home owners or the "friend that knows how to do it". Minor repairs don't typically result in major issues, however, there are a number of repairs/renovations that can weaken the structural integrity of the units (plumbers/handyman cutting out sections of floor joists because it's easier that way). Major repairs and renovations typically require permits through Manchester Township due to the extent of the scope of work, which is why Manchester will come in after to make sure the work was done completely. These repairs and renovations, if not done properly, can cause structural damage to the building, fire hazards in the case of improper electrical work and health hazards in the case of improper plumbing repairs/installations. If the correct procedure is not adhered to, the resident will be held liable for damages or losses resulting from improper work. Any changes in the scope of work needs to be communicated with either the Maintenance Department or the Trustees Office. Because of the amount of additional work this is generating for the Maintenance Department and the extra cost the Board of Trustees are absorbing to correct the repairs, major revisions are coming with regards to the Permission Request process from request to final inspection.

Prior to completing any work that would fall outside of your normal Maintenance related tasks (including window replacements, door installations, removing walls, moving or adding electrical fixtures, moving or adding plumbing fixtures, any major renovation, etc.) permission must be sought and granted by the Board of Trustees, even if you are not sure, it doesn't cost anything to ask either the Trustees Office or the Maintenance Department. The aforementioned up-

dated Permission Request Form will need to be filled out with all applicable information including drawings, descriptions and specifications for added equipment/utilities and turned into the Trustees Office. As part of the request process, you must supply contractor contact information and a Certificate of Insurance from the contractor that is to include general liability, auto insurance, workers compensation, employers liability and show that Crestwood Village Co-op, Inc. is an additional insured for the work performed in the village. The certificate will be reviewed by the Co-op for approval or denial. The Co-op is not approving, guaranteeing or endorsing said contractor. For these major renovations, after the Board of Trustees receives and reviews, the request is sent to the Maintenance Department for an on-site inspection to review the scope and determine if the work is allowed. If the work is approved, the Trustees Office will issue you an approval card to post in your window to allow everyone to see that you are completing the work as required. If you have a subcontractor working at your residence and you do not have this approval noted, a stop work order can be made and will not be able to resumed until the applicable information is delivered to the Trustees Office. The homeowner or contractor is responsible for obtaining the required permits from Manchester Township.

ANY MODIFICATIONS NOT APPROVED BY THE BOARD OF TRUSTEES MUST BE RETURNED TO THE ORIGINAL CONDITION WHEN THE UNIT WAS PURCHASED AT THE COST OF THE RESIDENT.

The old adage of "You get what you pay for" is definitely words to live by when it comes to repairs or renovations to your residence.

Manchester Coordinating Council

monthly meeting January 27, 2020

Melissa Deputy Director from Manchester Twp Senior Services attended the meeting to give a presentation on the services available through **Senior Services. 732-849-8305.** This service is funded through a grant through the Older Americans Act and a grant from Ocean County. They offer medical transportation for all seniors in our community. They will go to 7 different towns; Manchester, Brick town, Toms River, Silverton, Lakehurst and Lakewood. Call the office to make an appointment for services needed between 10-10:30 AM and 1-1:30 PM. You are encouraged to make your appointment in as far advance as you can. Transportation and assisted transportation is available. They do evaluations for the meals on wheels program. This can be home delivered meals or service at the nutrition site which is at the Community Reform Church in Whiting. This service is one hot meal per day and runs Monday through Friday. There is the fulfill program which is an emergency need for food; groceries are provided for someone in need. Different resources are available for adult daycare, Respite care etc. Also Pharmaceutical assistance PAD program. They will assist you with the application. Property tax deductions and Veterans deductions and benefits were mentioned. There are many other services available. **Call 800-792-9745.**

Councilmen gave an update on the Manchester Twp paid emergency management service. The Director has been hired. 130 responses for employment received. 5 ambulances were purchased in the summer and being filled with the required equipment. Approximately 50-60 employees will be hired to fulfill 7 day per week 24 hour service. Oral and physical testing in process. When the township service is in effect there will not be balance bill after insurance payment from the township service.

Water pipes work still in process from Heritage mineral site. Councilmen explained where the pipes are going. 2240 new homes were approved by the township at this site of 1000 acres of which 300 of these acres are lakes. Pipes are put in by the builder, water is provided by the township, township bills for the water. They are tapping into the well around the corner by the bend and going down schoolhouse.

State planning section DEP is defining township centers. Right now Manchester has 30% impervious. We can only have 30% of any lot covered by water that won't roll off. Buildings, parking lots, things of this nature. Neighboring towns have different percentage rates. We are limited by these state rules. We asked for a center exemption for parts of Route 70 and Route 37.

A participant discussed the replacement of trees when a tree is removed. Also if a wetland is removed is should be re-created and monitored to make sure it works.

There were contracts for water collies to scare the Canadian geese at Harry Wright Lake. Question from a participant is if we will have the water collies this year. Participant speaking stated the collies help scare the geese away.

Next meeting is Monday February 24th.

Guest speaker is Karen who will discuss Rain Gardens.

Everyone is invited to attend these very informative meetings, they are held on the 4th Monday of the month at 1:30 PM at Village 5 meeting room. See you there!


1. BE SURE TO READ ALL THE QUALIFICATIONS IN THE PTR BOOKLET BEFORE FILING FOR A REIMBURSEMENT.
2. Save this letter, it is the written proof from the Co-Op that you need to show how much was paid in taxes.

Send a copy of this letter with your forms, it will serve as proof and as a verification signature.

Other than supplying the tax figures for our residents, this office doesn't have anything to do with Property Tax Reimbursement. **IF YOU HAVE ANY QUESTIONS, DO NOT CALL THE TRUSTEE'S OFFICE, YOU MUST CALL THE PHONE NUMBER IN THE INSTRUCTION BOOK.**

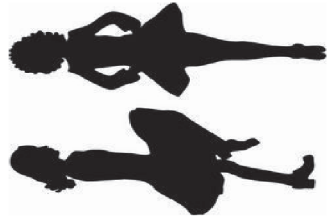
