Somebody Cares President David Smith gave an excellent presentation on the history and function of Somebody CARES. CARES is a non-profit organization serving over 20,000 senior residents in Whiting. Their Mission: Seniors helping other seniors. They depend completely on contributions. Services included are: Dial a Ride Services 732-350-2900 you can call from 24 hours to 2 weeks in advance for a ride. Drivers will take resident to almost any location in the Whiting area and return them to their homes. No fee for any service, donations are accepted. Free pick up and delivery for wheel chairs, walkers, crutches canes, etc. Items are on a loaner basis. Living Will Information, Attorneys, Money management, Notary Public, Senior Services, PAAD Assistance, Senior Gold Information, Daily Wellness Calls, Greeting Cards to Nursing Homes, Welcome Home Dinners upon dismissal from hospital, and monthly food truck.

What You Should Know About Getting Towed

The amended Predatory Towing Prevention Act became effective in New Jersey on April 15, 2009. The amended Act regulates tows from private property, and tows initiated by law enforcement, without the prior consent of the vehicle's owner or operator.

TOWING FROM PRIVATE PROPERTY

Unattended cars cannot be towed from private parking lots, unless:

- There is a sign, no smaller than 36" high by 36" wide, posted at vehicular entrances to the property stating:
 - 1) The purposes for which parking is authorized;
 - 2) The times when parking is permitted;
 - That unauthorized parking is prohibited and unauthorized vehicles will be towed at the owner's expense;
 - 4) The name of, and contact information for, the towing company and the address of the storage facility—which must be secure and located within a reasonable distance of the property—to which the vehicle will be towed;
 - 5) The charges for towing and storage and the times during which the vehicle may be redeemed; and
 - 6) Contact information for the Division of Consumer Affairs (1-800-242-5846).
- The property owner and the towing company have a contract for the towing and the property owner has authorized the towing company to remove the particular vehicle.

The requirements do not apply to a single-family home or an owner-occupied multi-unit structure, and the signage require-

ments are different for a residential community with clearly marked assigned spaces for residents.

UNLAWFUL PRACTICES FOR TOWING COMPANIES

The Act prohibits towing companies from the following:

- Failing to release a vehicle hooked or lifted, but not actually removed from private property, upon request of the vehicle's owner;
- Trolling (cruising) for vehicles parked without authorization:
- Paying for information about vehicles parked without authorization;
- Refusing to accept an insurance company check or a debit card, charge card, credit card or check for towing or storage services, if the towing company ordinarily accepts such payment at its place of business;
- Charging for a towing or storage service not on the Division's schedule of services; and
- Charging an unreasonable or excessive fee.

TOWING AND STORAGE CHARGES

The towing company's fees must be reasonable. A reasonable fee is considered one that is no more than 25% greater than the company's fee for the same vehicle-owner-approved towing services, or no more than 50% above the fees charged by other towing companies in the community for the same towing services without the vehicle owner's permission.

Towing and storage charges cannot exceed rates set by town ordinance.

I hope this month's Maintenance Minute finds everyone well during these very trying times. I would like to express my gratitude and appreciation to everyone for their patience and understanding over the past few months, unfortunately we are going to call on your patience and understanding once again in light of the increasing cases of COVID-19 nationwide and in our backyard.

In an attempt to keep everyone safe and hopefully healthy, the Maintenance Department has been instructed to reassess our current situation and scheduling moving forward. The Maintenance Department is going back to addressing interior emergencies only (heating, plumbing, electrical, roof leaks) and exterior work around the village. Interior non-emergency related work requests will be added to a list and taken care of at our earliest availability. If you are in need of any of these services or have questions on how your situation pertains to the current state of affairs, please call the Maintenance Department. We are here during regular business hours and if you call during those hours, there is no \$60 charge for any requested emergency type interior work. If you call after hours or on the weekends, the \$60 charge will be billed to you.

For all work requests moving forward, residents are to call the Maintenance Department, the Trustees Office or provide a written request which can be delivered to the mailbox in front of Friendship Hall or the box located outside the Maintenance Department door. THE MAINTENANCE DEPARTMENT IS CLOSED TO ALL NON-EMPLOYEED PEOPLE AND YOU WILL BE REQUESTED TO CALL OR DROP OFF WORK REQUESTS.

When you are being serviced by the Maintenance Department, we request that you have a mask on, show them where the issue is and then keep your distance and allow them to complete their work while following the safe distancing rules. They will notify you when the work has been completed and will provide any information or further instructions at that time.

The Maintenance Department reserves the right to leave your job if the above instructions are not followed and your work will then be rescheduled at a later date.

If you cannot wait and you feel that you will be contacting a contractor to handle your request, please remember that in most cases a Permission Request Form will need to be submitted to the Trustees Office so that we can made aware of work being completed and if the contractors you are utilizing are on the Trustees Office approved contractor list and to ensure they are caring the appropriate insurance.

Thank you in advance for your cooperation and patience during these difficult times as we continue to work through this.
